Gati profit surges 83%

Hyderabad, May 7

Logistics firm Gati has reported an 83 per cent increase in its consolidated net profit for the quarter ended March 31 at ₹13.8 crore, up from ₹7.5 crore in the year-ago period.

Turnover during the quarter stood at ₹386.5 crore, up 20 per cent from ₹321.7 crore in the corresponding quarter of last fiscal. Gati-Kintetsu Express, the joint venture between Gati and Kintetsu, contributed revenues of ₹11 crore during the quarter and helped it acquire six new clients in the apparel, imaging, IT and pharma space. ગતિનો ચોખ્ખો નફો માર્ચ ક્વાર્ટરમાં 83 ટકા ઊછળ્યો

મુંબઇ: અગ્રણી લોજિસ્ટિક કંપની ગતિ લિમિટેડનો ચોખ્ખો નફો માર્ચ ૨૦૧૪ ક્વાર્ટરમાં ૮૩ ટકા વધીને ₹૧૩.૮૧ કરોડ થયો હતો. કંપનીએ અગાઉના વર્ષના સમાન ગાળામાં ₹૭.૫૫ કરોડનો ચોખ્ખો નફો કર્યો હતો. આ સમયગાળામાં ફુલ આવક ₹૩૧૬.૫૯ કરોડથી વધીને ₹૩૮૩.૨૯ કરોડ થઈ હતી. માર્ચ ૨૦૧૪માં પૂરા થયેલા નવ મહિના દરમિયાન ટેક્સ પછીનો ચોખ્ખો નફો ₹૨૮.૩૧ કરોડ રહ્યો હતો, જે અગાઉના વર્ષના સમાન ગાળામાં ₹૧૦.૦૭ કરોડ હતો. બીએસઇ પર ગતિના શેરનો ભાવ બુધવારે ૧.૩૭ ટકા વધીને ₹૮૪.૮૫એ બંધ આવ્યો હતો.





హైదరాబాద్, మే 8: రవాణా వ్యవస్థలో పొందిన గతిఎక్స్ సైస్ రవాణా సంస్థ - లెమిటెడ్ ఈన3వ డ్రైమాసికంలో నికరలాభాలు 83శాతం పెరిగి 13.8కోట్లకు చేరినట్లు కంపెనీ ప్రకటిం బింది. మ్రతి త్రెమాసికం వారీగా చూస్తే 20 శాతం పెరిగి 386.5 కోట్లకు చేరినట్లు తేలింది. పన్నుల చెల్లింపులకు ముందు లాభం 32.2 కోట్లు ఉంది. గత ఏడాదితో పోలిస్తే 43శాతం పెరగింది. పన్నుల చెల్లింపుల అనంతరం నికర లాభం 13.8కోట్లకు చేరింది. గత ఏడాది ఇదే మూడునెలలకుగాను 7.5 కోట్ల మాత్రమే ఆర్జించింది. కంపెనీ మొత్తం టర్నోవర్963.2 కోట్ల నుంచి 17శాతం పెరిగి 1127.1 కోట్లకు చేరింది. పన్నుల చెల్లింపులకు ముందు లాభాలు 94.7 కోట్ల ఉంన్నాయి. పన్నుల చెల్లింపుల తర్వాత కంపెనీ గతేదాది 10.10కోట్ల లాభం నుంచి ఈ ఏదాది 181శాతంపృద్ధిచెంది28.3కోట్లకు కోగలిగినట్లో గతివ్యవస్థాపక సింబ మహేంద అగర్వాల్ వెల్లడించారు. గతి కింటెట్స్లు ఎక్స్ (సెస్, గతికౌనర్, గతిఆకామర్స్ వంటి సంస్థలు లాభాల్లోనే నడిచాయని ఆగర్వాల్ వెల్లడించారు.
