Gati's Q3 profit zooms 124%, despite drag in shipping biz

Hyderabad, May 11 Despite the continuing drag in its shipping business, supply chain solutions pro-vider Gati Ltd has clocked a 124 per cent rise in its net profit for the quarter ended

March 31, 2012 Its net profit touched Rs 8.05 crore, as against Rs 3.6 crore in the year ago period. Its income during this period was Rs 210.65 (Rs 228.69).

The increase in profit was largely contributed by a prof-it on sale of land of Rs 7.26

crore during the quarter. It SHIPPING DIVN has a more positive outlook for 2012-13, as its new joint venture with Japan's Kintetsu World Express (KWE) is expected to contribute to its bottomline.

"The slowdown in the economy has become a major

challenge.
"While our revenues show modest growth, we believe that the express distribution business will grow significantly above the industry average (after the KWE partnership)," Mr Mahendra Agarwal, Chief Executive Officer of the company, said

The shipping division continued to incur losses, dampening the overall financials of

the company.
This division registered a de-growth and the losses (excluding the exceptional item) stood at Rs 27 crore year-onyear for the nine months ended March 31, as against a Rs 10.5-crore loss in the yearago period.
