Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and amendment thereto.

Pursuant to the provisions of Regulation 30 of the Listing Regulations, we would like to inform you that the Company has entered into a Share Purchase Agreement ("SPA") Dated August 17, 2020 with Gati Asia Pacific Pte Ltd., a wholly-owned subsidiary ("GAPAC") and Allcargo Belgium N.V. ("Allcargo Belgium") and Wingdom APAC Limited ("Wingdom"), for sale/disposal of the entire equity holding in GAPAC by the Company, in favour of Allcargo Belgium and Wingdom.

Pursuant to the aforesaid SPA, the Company has transferred its entire equity holding in GAPAC to Allcargo Belgium and Wingdom on August 17, 2020. Therefore, post the aforesaid transfer, GAPAC has ceased to be the Company's wholly-owned subsidiary with effect from August 17, 2020.

Further pursuant to the requirement of the Securities and Exchange Board of India circular CIR/CFD/CMD/4/2015 dated September 09, 2015 disclosure is enclosed herewith as Annexure.
